General Rules and Guidelines

All Buyers, Consigners, Sellers, Browsers, and Guests Agree to Abide by These General Rules and Guidelines

- All Participants must register at the Front Desk before entering Auction Facility and Bidding.
- All Browsers and Guests must pay a \$10 entrance fee, that will be refunded if registers as a buyer.
- All Participants, Browsers, and Guests must be at least 18 years old. No pets allowed.
- All Public buyers must place a \$50.00 refundable deposit down to bid.
- All bids won by non- dealers must be paid on the day of sale.
- There will be Buyers premium on all purchases of 10%.
- Sales Tax will apply ON ALL TAXABLE ITEMS, without proof of VALID FLORIDA TAX NUMBER presented at time of registration. Taxes will be collected based upon your State of Residence.
- There is a 4% convenience fee for use of a Credit or Debit card to pay for fees or purchases.
- All Purchases must be picked up within 48 hours of sale or we will assess the Buyer a \$25 fee.
- All unsold units must be picked up within 48 hours of sale or we will assess the Seller a \$25 fee.
- All announcements by the auctioneer will take precedence over any previously printed material or oral statements made.
- The Auctioneer in charge will settle any disputes as to bids.
- The Auctioneer's decision on such matters is FINAL LIABILITY: All persons attending the auction and/or facility do so at their own risk. Neither the sellers, nor Auctioneers, nor any other person of business connected with the Auction assumes any liabilities, legal or other in the event of an accident may occur.
- Auctioneer reserves the right to accept bids in any increment he feels is the best interest of his client, the seller.
- ABSOLUTELY NO FIREARMS AND/OR DRUGS WILL BE ALLOWED ON AUCTION PROPERTY.
- Auction is merely the selling agent for the consignor.
- All bids are binding and may not be retracted for any reason once submitted.
- All items are sold "AS-IS WHERE-IS" with no warranty of any kind, know what you are bidding on. We do not know of any possible existence of defects other than announced conditions.
- Inspections of items are the sole responsibility of the bidder. You must be aware of what you bid on.
- The Auctioneer reserves the right of reject, the bidding and/or the removal from auction facility of any person whose conduct, actions or adverse comments he feels is not the best interest of the seller or other bidders.
- PUBLIC BUYERS PURCHASING VEHICLES WILL BE REQUIRED TO PAY ADMINISTRATION FEE, TITLE REGISTRATION AND TAG FEES ACCORDING TO FLORIDA DMV. TITLES WILL NOT BE RELEASED ON AUCTION DAY! TITLES WILL BE MAILED AS PROCESSED.
- ALL ITEMS MUST BE PAID IN FULL ON SALE DAY, UNLESS PRIOR ARRANGEMENTS ARE APPROVED BY AUCTION MANAGEMENT.
- If it becomes necessary for the seller or auctioneer to commence an action to enforce the terms of this agreement or to collect a check returned for nonsufficient funds or stop payment, the purchaser and/or maker of the check agrees to pay all attorney fees incurred.
- All purchases must be paid in full the day of the Auction: in US funds, cash or cashier's check. Any business check must be accompanied by a Bank Letter of Guarantee and approved by Auction Management.
